Ube Industries Announces Organizational and Personnel Changes

TOKYO, February 26, 2015 —Ube Industries, Ltd. has announced that the company's Board of Directors decided today on the following changes to its internal organizations, directors, executive officers and their assignments. Change of directors is scheduled to be formally approved by the general meeting of shareholders planned for June 26, 2015 and the meeting of the Board of Directors that will follow it.

Ube Industries has issued a separate announcement today concerning changes to its representative directors.

I. Changes in Internal Organization

Date of Issue: April 1, 2015

A. Establishment of Chemicals Company

- 1) Chemicals & Plastics Company and Specialty Chemicals & Products Company will be integrated into Chemicals Company.
- 2) Ube Industries will establish Strategic Operational Department in Chemicals Company to oversee the business and technology strategy. Furthermore, the management function of Planning and Administration Dept. of Chemicals & Plastics Company and Strategy Planning Dept. of Specialty Chemicals & Products Company will be integrated into the new 'Management Department'.
- 3) Ube Industries will create a new Chemicals Quality Assurance Department in the Chemicals Company to further strengthen the framework for chemicals quality assurance.
- 4) Ube Industries will establish Engineering Plastics, Caprolactam and Industrial Chemicals Business Unit integrating the Engineering Plastics Business Unit and Caprolactam & Industrial Chemicals Business Unit
- 5) Ube Industries will establish Polyimide and Specialty Products Business Unit integrating the Polyimide Business Unit and Specialty Materials & Products Business Unit.
- 6) Ube Industries will establish Battery Materials and Fine Chemicals Business Unit integrating the Advanced Battery Materials Business Unit and Fine Chemicals Business Unit.

B. Changes to Production Technology Division

- 1) All development center in Production Technology Division will be controlled directly by Chemicals Company. Production Technology Division will be renamed as 'Production Division' in the Chemicals Company.
- 2) Following organizations in Production Technology Division will be eliminated: Administration Center, Production Center, Planning and Coordination Dept., Automotive Materials Development Center.

C. Changes to overseas operational units

Europe Operational Unit and Asia Operational Unit will be controlled by Chemicals Company. The Europe Operational Unit will be renamed the Europe and Americas Operational Unit, expanding its territory to cover the group companies in the Americas.
